

BIG ASS LIGHT BAR WARRANTY



Big Ass Light, LLC warrants its Light Bar to be free from defects in workmanship or material under normal use and service for five years from the date of shipment to the customer. Batteries and other accessories are limited to one year. This warranty is limited solely to products purchased directly from the Big Ass Solutions family of companies or from one of its authorized dealers. Under no circumstances will warranty coverage extend to products purchased through eBay, craigslist, or other internet auction or internet-based retail sites. Proof of purchase in the form of the serial number marked on the product will be required to qualify.

If Big Ass Light, LLC determines the product is defective, Big Ass Light, LLC will elect, in its sole discretion, to refund the purchaser the purchase price of the product, repair the product, or replace the product. Warranty coverage is contingent upon proper use in the application for which the product was intended and does not cover products which have been modified or repaired without Big Ass Light, LLC approval, or on which original identification marks have been removed or altered.

This warranty does not cover loss or damage to the product caused by negligence; abuse; misuse; mishandling; improper storage; damage due to fire or acts of God; vandalism; normal wear and tear; battery leakage; power surges; improper power supply; electrical current fluctuations; corrosive environments; induced vibration; accident; modifications or attachments to the product not approved by Big Ass Light, LLC; failure to follow installation, operating, or maintenance instructions prescribed by Big Ass Light, LLC or applicable electrical codes; damage caused by the carrier in-transit, which is handled under separate terms; tampering of components that compromises the integrity of the water-tight seal; submersion in water deeper than one meter or for longer than 15 minutes; or improper service of the product performed by someone other than Big Ass Light, LLC or its authorized technical service providers.

In all cases the responsibility and liability of Big Ass Light, LLC under this warranty shall be limited to the cost of the equipment. The purchaser must obtain shipping instructions for the prepaid return of any item under this warranty provision and compliance with such instruction shall be a condition to make any claim under this warranty.
